The Suffolk Regional EMS Council's nominations are based on applications submitted by **YOU**. Applications are now being accepted for events that occurred **in 2018**, or on behalf of individuals, team or organizations that have demonstrated an ongoing commitment to EMS through 2018. State awards will be presented at the annual Vital Signs conference in October 2019 in Syracuse, NY.

It is our long-standing tradition that every nominee is honored by the Suffolk Regional EMS Council at its annual ceremony at a date and location to be announced in the future. Applications must be received by the Suffolk Regional Council **before March 13, 2019** to be considered. *The deadline listed on the bottom of the application refers to the State deadline, and not the Suffolk REMSCO timeline.*
